Ken led a discussion regarding the WDSF Code of Ethics/Conflict of Interest Policy and how they relate/should relate to USA Dance. This issue needs to be brought to the GC. Some things to consider:

- Job description issues inside of the DanceSport realm
- Two issues have come to light from past conflict of interest issues
  - 1. Do we want a DS Delegate to also be a Judge?
  - 2. Do we want a DS-VP, President, Exec-VP, Treasurer, Social-VP, Secretary to be a person that derives income from a sanctioned USA Dance activity? In other words judging, emceeing, organizing/owning a competition, training camp, etc.
